



CONCLUDING STATEMENT
Special Meeting on SEANF Strategic Plan 2017-2021
Komnas HAM, Jakarta, Indonesia
23-24 August 2016

The South East Asia National Human Rights Institutions Forum (SEANF) held Special Meeting on SEANF Strategic Plan 2017-2021 which was hosted by the Indonesian National Commission on Human Rights (Komnas HAM) and chaired by the Myanmar National Human Rights Commission (MNHRC) in Jakarta, Indonesia on 23-24 August 2016. The Members of the SEANF – the Indonesian National Commission on Human Rights (Komnas HAM), the Human Rights Commission of Malaysia (SUHAKAM), the Myanmar National Human Rights Commission (MNHRC), the Commission on Human Rights of the Philippines (CHRP), the National Human Rights Commission of Thailand (NHRCT) and Provedoria dos Direitos Humanos e Justica (PDHJ) of Timor Leste attended the meeting.

The main outcomes of the Meeting are as follows:

1.0 Adoption of the Agenda

1.1 The Agenda for the Special Meeting on SEANF Strategic Plan 2017-2021 was adopted without amendment.

2.0 Special Meeting on SEANF Strategic Plan 2017-2021

2.1 SEANF Members welcomed the presentation by Komnas HAM on the draft of the Strategic Plan 2017-2021 and also agreed on the final draft of the Strategic Plan 2017-2021 to be adopted at the 13th Annual Meeting of SEANF in Nay Pyi Taw, Myanmar.

3.0 SEANF Permanent Secretariat

3.1 SEANF Members welcomed the updates by Komnas HAM on the proposed establishment of SEANF Permanent Secretariat.

3.2 SEANF Members thanked Komnas HAM for preparing the Roadmap for SEANF Permanent Secretariat and requested Komnas HAM to improve the document.

3.3 Komnas HAM agreed to circulate the draft Statute and proposed budget including the proposed annual contribution of SEANF Permanent Secretariat to SEANF Members by 9 September 2016. SEANF Members are requested to send inputs/suggestions for the both documents, if any, by 16 September 2016.

4.0 The 13th Annual Meeting of SEANF

- 4.1 SEANF Members discussed the provisional agenda of the 13th Annual Meeting of SEANF and the provisional agenda will be revised accordingly.
- 4.2 In accordance with paragraph 10.3 of the Concluding Statement of SEANF – TWG (2/2016), a seminar relating to NHRI relations with legislature, executive and judiciary will be held on the morning of 27 September 2016. SEANF Members are requested to confirm the names of moderators and speakers by 16 September 2016.
- 4.3 In accordance with paragraph 6.2 of the Concluding Statement of SEANF – TWG (2/2016) a statement on the Rights of Older Persons will be issued at the end of the 13th Annual Meeting of SEANF. SEANF Members are requested to send inputs for the statement by 16 September 2016.
- 4.4 SEANF Members agreed to invite potential donors to the session on SEANF Permanent Secretariat at the 13th Annual Meeting of SEANF on 27 September 2016, in Nay Pyi Taw, Myanmar.

SEANF Members highly commended the excellent facilitation of the Special Meeting by the Chairperson of SEANF and hospitality extended to all the participants by Komnas HAM.
